Contractor must have Explosive Vans fabricated/made up as per Explosives Rules-2010 and duly approved by the Inspectorate of Explosives. No transportation shall be allowed through vehicles other than approved by Director General of Explosives. Drivers must be in possession of valid driving license. Contractor must provide complete detail of drivers, X-Vans, X-Vans must have tracking active system and regular monitoring report to be submitted with each bill. Contractor must submit properly received D.Os (Signature, Name & Stamp) for processing. Contractor must charge for his services in compliance with agreement.

GENERAL TERMS/CONDITIONS

M/s _____ as carriage contractor undertake that:

1. The rate running carriage contract will remain operative from **01-07-2025 to 30-06-2027**. It may be extended to any period on the same rates, terms and conditions or terminated during currency of the contract by mutual consent of both the parties subject to approval of competent authority.
2. The carriage contractor will be bound to provide demanded X-Vans when required by Logistics Department at Wah Nobel Wah Cantt.

3. Transporter will be responsible for the safe delivery of Explosives. Cost of goods found short or contaminated or loss due to accident or for any reason will be recovered from their bills/security deposit. The contaminated material, being a special item, will be retained by the Company and disposed off as and when and in the manner deemed necessary and cost of disposal shall also be recovered from transporter. Transporter shall have no claim whatsoever regarding the said contaminated material.
4. After delivery of the materials in safe and sound condition at destination, the payment shall be made through crossed cheque to the transporter on presentation of invoice, bilty & D.O's under a covering letter.
5. The carriage contractor shall ensure that each hired X-Vans carries maximum load to its capacity keeping in view weight, volume and shape of the consignment.
6. In case of any accident or defect caused to the hired X-Vans en-route, the transporter will be responsible to replace such X-Vans without any loss of time and at their own cost and no extra payment shall be allowed.
7. The carriage contractor will ensure to provide road-worthy transport to demanding concerned department and the later will confirm that the transport provided is in road-worthy condition absolutely and meeting their requirement
8. In case the transporter fails to provide the demanded X-Vans in time, a fine @ 5% of quoted rates per vehicle will be imposed, this will be deducted from the carriage contractor's bill.
9. In the event of any dispute arising out of the terms of this contact / agreement, the matter will be referred to arbitration. The Chief Executive (Wah Nobel) of the company will be the sole arbitrator and his decision shall be final and binding on us.
10. In case the carriage contractor fails to provide X-Vans etc on demand or tries to back out of his contractual obligations or does not take interest in the contract or violates the terms and conditions of the contract or as provided in this quotation, the contract will be cancelled and the work for the remaining period will be got done at the risk and cost of the transporter.
11. The carriage contractor shall not employ any person of doubtful character or with record of previous conviction or considered undesirable from safety / security point of view.
12. The transporter entity will be required to notify in writing to the accepting Officer any change in the constitution of the entity or any change of address thereof. The accepting officer may not accept the new party or any change thereof; and in this case the owner, director or partners of entity will remain responsible for the execution of this contract for all intents and purpose.
13. The carriage contractor does hereby agree to abide by and fulfill all terms and conditions of the carriage contract/quotation and agrees to pay to Wah Nobel compensation as assessed by the accepting officer for any breach of the agreement. It may include termination of contract without notice and forfeiture of Security Money or fine or both.
14. The carriage contractor will provide mechanically fit and better condition X-Vans, and not extremely poor and of old vintage vehicles, duly possessing necessary auxiliary

requirement viz: Tarpaulin, Jack, Spare Wheels etc. The drivers will carry their requisite documents i-e. Original Registration, Driving Licence and CNIC etc during the Journey and while entering the Factories.

15. The carriage contractor will deposit Rs.1,000,000/- (rupees ten hundred thousand only) as security deposit at call in favour of the Company (Wah Nobel (Pvt) Ltd) with Accounts Department, Wah Nobel, Wah Cantt, which shall be refunded on successful completion of the contract and on submission of "NOC" (NO DEMAND CERTIFICATE) from General Manager Admin & Logistics.
