One 32 Seater Hino Bus Air Conditioned with driver, which shall provide pick & drop services to General Shift employees from fixed stop Taxila/Wah Cantt to WND Plant, Hattar & back (05 days a week). The average coverage per month shall be 2,400 Kms approximately. Supply of POL and all sort of vehicle maintenance shall be the responsibility of transport contractor. The vehicle should be in original condition with 2015 or up model.	
2.	One 24 Seater Toyota Coaster Air Conditioned with driver, which shall provide pick & drop services to General Shift Staff & Officers from Taxila to WND Plant Hattar via Wah Cantt. (05 days a week). On overtime The van will pick the Shift Incharge from his home and staff from fixed stops at Taxila/Wah Cantt to Hattar and back. The average coverage per month shall be 2,400 Kms approximately. Supply of POL and all sort of vehicle maintenance shall be the responsibility of transport contractor. The vehicle should be in original condition with 2015 or up model.	
3.	One 14 Seater Toyota Hiace Van Air Conditioned with driver, which shall provide pick & drop services to General Shift Staff & Officers from Taxila to WND Plant Hattar via Wah Cantt. (05 days a week). On overtime The van will pick the Shift Incharge from his home and staff from fixed stops at Taxila/Wah Cantt to Hattar and back. The average coverage per month shall be 2,400 Kms approximately. Supply of POL and all sort of vehicle maintenance shall be the responsibility of transport contractor. The vehicle should be in original condition with 2015 or up model.

GENERAL TERMS/CONDITIONS

1. The validity of quotation shall be 45 days.
2. The duration of contract shall be for two year.
3. Time keeping for pick & drop as instructed by Plant Manager and regular attendance shall be the essence of contract.
4. On Company requirement contractor is responsible to provide pick & drop services on Saturday/Sunday overtime at the contracted rate, these extra charges will be paid at the end of the month in addition to the per month contract bill.
5. In case the contractor failed to provide transport to WNDL as per contract. WNDL shall arrange transport at contractor's risk and cost. The additional expenses thus incurred shall be borne by contractor & WNDL shall deduct the same amount from contractor's monthly payments of bills/security deposit.
6. WNDL reserves the right to terminate this contract and/or to forfeit the security deposit for breach of any clause, or failure to provide required transport services.
7. To obtain entry permit of vehicle into POF area shall be the responsibility of transport contractor. However WNDL shall extend the maximum cooperation in this regard.
8. Along with quotation the transport contractor shall submit security deposit of sum of Rs.50,000.00 (refundable) in the form of DD/CDR/Pay Order in favour of Wah Nobel (Pvt) Limited.
